## What is the Compliance Indemnity?

2. not prevented us from carrying out our duties;
3. not waived our responsibility in respect of any matter;
4. paid Leaders Compliance Indemnity Fee throughout the tenancy and
5. provided us with your immediate instructions and any funding required

Additionally this indemnity is subject to:

The full co-operation of your tenant with timely access granted where necessary. An indemnity will not be provided where a liability arises when your tenant has been in any way obstructive.

If we are not managing your property and our instruction is on a Rent Collection basis, you must adhere to your contractual maintenance obligations and be sure your property is in a good state of repair.
