

KINGTON MARKET
FAT SHEEP REPORT
THURSDAY 8th AUGUST 2019

McCartyneys of Kington report a very good entry of 2711 sheep on Thursday last the 8th of August

A very good entry of sheep sold to an excellent trade in all sections. The sheep trade has firmed this week due to the upcoming Muslim festival early next week. The weakening of the Pound against the Euro has also helped to stimulate demand in the sheep industry.

LAMBS

We had a very good entry of 2249 lambs, which sold to an excellent trade on the week.

The buyers had good orders for all types of lambs and bid well for all weight ranges. The heavier weight ranges over 44kg would be the best weights to sell on the day.

The lambs averaged an excellent £1.90ppk up to £2.00ppk from Messrs Watkins and sold up to £94.50 per head for some 48kg lambs from HJW Hammonds.

The whole lamb section from the lightest to the heaviest in the market averaged an excellent £83.50 per head.

Lambs between 25 to 32 kg averaged 1.75ppk up to 1.88ppk which averaged £57 per head
Lambs between 32 to 39 kg averaged 1.80ppk up to 1.82ppk which averaged £63 per head
Lambs between 40 to 45 kg averaged 1.90ppk up to 2.00ppk which averaged £83 per head
Lambs between 46 to 52 kg averaged 1.88ppk up to 1.98ppk which averaged £90 per head

Our light lamb section for lambs under 35kg sold to a good trade and averaged £1.77ppk up to £1.80ppk. All light lambs averaged a good £59 per head for lambs weighing from 28kg to 35kg.

We are fortunate to have excellent buyer support from 7 regular buyers giving excellent competition for the spring lambs each week.

CULL EWES, TUPS, WETHERS, STORE HOGGETS & GOATS

There was a good entry of 462 cull & store sheep, which sold to a strong trade on the week.

The strong meated well-bred cull sheep would be the best trade. We had a very large number of smaller, thinner and hill ewes forward again this week and these sold to a strong trade with new buyers looking for grazing ewes.

The buyers are currently requiring good meated sheep for their orders and there is also good demand for grazing ewes.

All types of cull sheep were in good demand.

The cull sheep sold to a top of £100 per head for some Texel x ewes from CR Evans and averaged a good £58 per head.

Continental x and strong ewes averaged £87 per head and sold up to £100 per head.

Mule type ewes averaged £60 per head and sold up to £78 per head.

Welsh, Speckle and smaller hill type ewes averaged £48 per head and sold up to £65 per head.

Tups sold to £80 per head and averaged £69 per head.

We have buyers for in excess of 2000 lambs and 750 cull sheep per week to meet our buyers' requirements.

FARM ASSURANCE AND GREEN FORMS

Please could all livestock entries be accompanied with a completed green form with correct and up to date farm assurance details on. If you are selling livestock which is stated that it is farm assurance then the details must be valid and up to date. Some sheep buyers can only buy farm assured stock and if they are found to be not assured after the sale or worse in the abattoir they will not process the sheep nor pay for them. If you have a farm assurance inspection and further information is required then please forward that information to the relevant office as the farm assurance schemes will suspend farm assurances and this then makes the livestock non farm assured.

SHEEP TAGGING AFTER 1st JANUARY 2016

We can accept all sheep tags for cull sheep at Kington Market at our weekly sale.

If you have any queries regarding this please give us a call for guidance.

All sheep BORN in England and Wales after the 1st January 2016 must be EID tagged either by a single or double tag depending on whether the animal will be a store/fat sheep or breeding sheep.

Vendors/Purchasers must satisfy themselves as to the correctness of information shown in relying upon it to meet their regulatory responsibilities."

C OVIS IN SHEEP

We are having a lot of problems with C Ovis in sheep when they are slaughtered. This condition is picked up from mainly dog muck when dogs have not been wormed. The abattoirs are condemning whole carcasses because of this as they are not allowed to enter the food chain. The cost of these deductions is becoming excessive. Please can you ensure dogs are wormed and we appreciate it is difficult to control dog walkers where you have foot paths going over your land. The abattoirs have now agreed to give us ear tag numbers of the affected sheep so we will be able to identify where problems are arising.
