

**KINGTON MARKET**  
**FAT SHEEP REPORT**  
**THURSDAY 12<sup>th</sup> DECEMBER 2019**

McCartneys of Kington report an entry of 1348 sheep on Thursday last the 12<sup>th</sup> December 2019 for their Christmas Show and Sale.

We had an excellent trade trough out with a lift in the trade from the beginning of the week.

The cull ewes have taken a significant rise particularly on the meated types.

### **LAMBS**

We had an entry of 1058 lambs which sold to an excellent trade throughout all weight ranges.

The lambs sold to an excellent trade throughout and being some bit dearer then previous sales reported earlier in the week. The lighter lambs between 32kg and 39kg were particularly sort after for the Christmas trade as can be seen from the averages below.

The buyers are requiring well-bred and good finished lambs for their orders which are not fat.

The lambs averaged an excellent SQQ of £1.94 ppk up to £2.34 ppk from WL & A Windsor

The lambs sold up to £96 per head for some 41 plus kg lambs from WL & A Windsor

The whole lamb section from the lightest to the heaviest in the market averaged an excellent £85 per head throughout the whole lamb section.

Lambs between 32 to 39 kg averaged 2.03ppk up to 2.12ppk which averaged £78 per head  
Lambs between 40 to 45 kg averaged 1.94ppk up to 2.34ppk which averaged £83 per head  
Lambs between 46 to 52 kg averaged 1.84ppk up to 2.02ppk which averaged £88 per head  
Lambs over 52kg averaged 1.74ppk up to £1.78ppk which averaged £92 per head

We had a good entry of light lambs which were in good demand by the buyers.

The light lambs ranged from 23 kg to 36 kg and averaged a very good £1.83 ppk (£60 per head) up to £1.90ppk (£70 per head).

The Champion pen of lambs was awarded to WL & A Windsor for some 41kg Texel x lambs which made £96 per head.

The Reserve Champion pen of lambs was awarded to MG & GJ Morgan for some 43kg lambs which made £95.50 per head

The lambs were kindly judged by Mr Percy Jenkins of Euro Quality Lamb of Craven Arms.

We are fortunate to have excellent buyer support from 7 regular buyers giving excellent competition for the spring lambs each week.

## **CULL EWES, TUPS, WETHERS, STORE HOGGETS & GOATS**

There was a good entry of 290 cull & store sheep, which sold to a very strong trade on the week for the types forward with excellent demand from the buyers on all types.

All types of ewes would generally sell well

The strong meated well-bred cull sheep would be the best trade again.

We had a better quality entry this week and a very strong following for the best meated sheep.

There are a number of buyers still wanting grazing ewes.

The buyers are currently requiring good meated sheep for their orders and there is also good demand for grazing ewes.

All types of cull sheep were in good demand.

The cull sheep sold to a top of £132.50 per head for some Texel ewes from WD Layton & Sons and averaged an excellent £70 per head.

Continental x and strong ewes averaged £93 per head and sold up to £132.50 per head.

Mule type ewes averaged £63 per head and sold up to £82 per head.

Welsh, Speckle and smaller hill type ewes averaged £48 per head and sold up to £60 per head.

Tups sold to £82 per head and averaged £73 per head

The Champion pen of ewes was awarded to EJ & HM Price for some Texel X ewes which made £131 per head.

The cull ewes were kindly judged by Mr Denis Bevan of Pak Mecca Meats of Birmingham

### **SHEEP TAGGING AFTER 1<sup>st</sup> JANUARY 2016**

We can accept all sheep tags for cull sheep at Kington Market at our weekly sale.

If you have any queries regarding this please give us a call for guidance.

All sheep BORN in England and Wales after the 1st January 2016 must be EID tagged either by a single or double tag depending on whether the animal will be a store/fat sheep or breeding sheep.

## **FARM ASSURANCE AND GREEN FORMS**

Please could all livestock entries be accompanied with a completed green form with correct and up to date farm assurance details on. If you are selling livestock which is stated that it is farm assurance then the details must be valid and up to date. Some sheep buyers can only buy farm assured stock and if they are found to be not assured after the sale or worse in the abattoir they will not process the sheep nor pay for them. If you have a farm assurance inspection and further information is required then please forward that information to the relevant office as the farm assurance schemes will suspend farm assurances and this then makes the livestock non farm assured.

## **C OVIS IN SHEEP**

We are having a lot of problems with C Ovis in sheep when they are slaughtered. This condition is picked up from mainly dog muck when dogs have not been wormed. The abattoirs are condemning whole carcasses because of this as they are not allowed to enter the food chain. The cost of these deductions is becoming excessive. Please can you ensure dogs are wormed and we appreciate it is difficult to control dog walkers where you have foot paths going over your land. The abattoirs have now agreed to give us ear tag numbers of the affected sheep so we will be able to identify where problems are arising.
