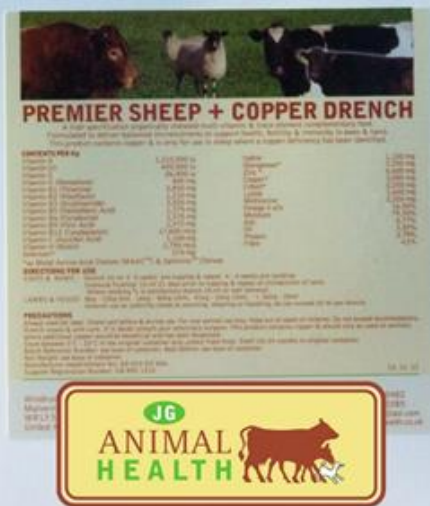

The above Order came into operation on 6th April 2007 and your attention is drawn to **Regulation 4, Schedule 1, Article 3 (3)**. Regulation 4 requires the owner of a bovine animal kept on any premises to mark or identify that animal in an approved manner, within 36 hours for a bovine animal born in a dairy herd and within 20 days for any other herd. Please ensure that your cattle are marked with an approved Ear Mark.

Conditions of Sale

All stock is sold under the Conditions of Sale as recommended for use by the Livestock Auctioneers' Association for England & Wales together with McCartneys Special Conditions as posted in the Market.
