## **Referral Promotion Terms and Conditions**

- 1. The 'Referral' Promotion ("the Promotion") is offered by Hamptons, a trading name of Countrywide Estate Agents, registered company number 00789476 and registered office address Greenwood House, 91-99 New London Road, Chelmsford, Essex, CM2 OPP ("Hamptons, us").
- 2. The Promotion is open to eligible customers only. Eligible customers are those who are aged 18 years or older, including employees of Hamptons but excluding any other persons who are in any way connected to this Promotion.
- 3. The Promotion will run for a limited time only from 00.01 on 1 August 2021 ("Start Date") and automatically terminate at 23.59 on 31 July 2022 ("the Promotional Period").
- 4. If you recommend Hamptons to a third party within the Promotional Period, and the third party goes on to sell or let their property with us ("Referral"), we will donate £250 to a local charity of your choice ("Donation"). Alternatively, at your request we will reward you with a John Lewis & Partners gift voucher worth £250 ("Voucher"). The Donation will be made or the Voucher awarded on receipt by Hamptons of the full sales or letting commission from that Referral.
- 5. You can refer as many third parties to us as you wish, but you will only be entitled to one Donation or Voucher per Referral. For example, if your Referral goes on to both sell and let a property with Hamptons, or sell two properties with Hamptons, or let two properties with Hamptons, you would receive only one Donation or Voucher.
- 6. The Promotion applies in respect of new Referrals only. - 10. If you have chosen for us to make a Donation on your behalf, we will endeavour to make the Donation within 60 days of receiving the Agent's Fee from your Referral.
- 11. The Voucher and Donation are non-exchangeable, non-transferable and no cash alternative is offered. The cash value of the Voucher and Donation is 0.00001p.
- 12. The Donation or Voucher is a one-off reward which applies only in respect of the first fee or commission or first tranche of a fee or commission received from a Referral. It does not, therefore,

- apply in respect of fees which may subsequently be earned from that Referral. Nor, save in respect of the first tranche of the fee received, does it apply to a fee paid in a number of tranches (for example, a letting fee payable on a periodic basis).
- 13. The Promotion does not apply in respect of any other fees or commission which may be received by Hamptons or its group companies, including but not limited to fees received from tenants, Comprehensive Property Management Service fees or renewals fees.
- 14. Hamptons are under no obligation to accept or follow up on Referrals made by you.
