

## LETTINGS 20% FEE DISCOUNT WHEN YOU PURCHASE THROUGH US

- The 20% Lettings Fee Discount ("the Promotion") is offered by Countrywide Estate Agents trading as Hamptons International ("Hamptons"), registered number 789476 and registered office at Greenwood House, 1st Floor, 91-99 New London Road, Chelmsford, Essex, CM2 0PP.
- The Promotion will be available for a limited time only from 09.00 hrs 20 July 2020 ("Start Time") and shall automatically terminate no later than 23.59 hrs 31 March 2021 ("Closing Time").
- The Promotion is only available to eligible customers. An eligible customer is one who is aged 18 years or over but excluding employees of Hamptons, any members of the immediate family of a Hamptons employee, and any other persons who are connected in any way to this Promotion ("Customer"). Proof of age and identity may be required.
