

TERMS & CONDITIONS FOR CANARY WHARF ICE SKATING PRIZE DRAW

1. The [Canary Wharf] Prize Draw is offered by Hamptons, a trading name of Countrywide Estate Agents, whose registered number is 00789476 and whose registered address is Greenwood House, 1st Floor, 91-99 New London Road, Chelmsford, Essex, CM2 0PP ("the **Promoter**").
2. There will be 2 separate prize draws (each a "**Draw**") taking place over 4 weeks, starting from [25/11/21]. The Draws will take place over the following dates:

Entries received outside of these dates and times will not be counted.

3. Each Draw is free to enter, but you do need your own active Instagram account and access to the internet.
4. The Promoter will post the Instagram image and competition on the Start Date, setting out details of the Prize Draw and inviting people to enter.
5. To enter the Draw you must like the Instagram post, tag 5 friends and for an extra entry into the Draw, share the post on your Instagram story. Please note that for any entry to qualify for the Draw, you also need to follow the Promoter's Instagram account by the applicable End Date.

You may enter each Draw more than once **and/or** you may enter more than one Draw.
